NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual promises and agreements contained herein, the client hires She Cares Daycare to work under the terms and conditions hereby agreed upon by the parties:

- a.) **Late Pickup.** If the parent(s) is going to be late picking up their child(ren), every effort must be made to contact the childcare provider. A late pickup fee of \$10 shall be administered if the parent(s) are more than 15 minutes

late after the child's pickup time. The late pickup fee shall be administered to each child that has not been picked up.

- b.) **Overtime Care (with approval).** If the parent(s) has received approval from She Cares Daycare for overtime care of the child(ren), the She Cares Daycare shall provide such care at a rate of \$10 per hour.
- c.) **Overtime Care (without approval).** If the parent(s) has not received approval from She Cares Daycare for overtime care of the child(ren), the childcare provider shall provide such care at a rate of \$20 per hour.

VI. Holidays. The parties acknowledge and agree that She Cares Daycare will not be available on the following national holidays:

- New Year's Day
- Memorial Day
- Independence Day
- Labor Day
- Veteran's Day
- Thanksgiving Day
- Christmas Day

VII. Payment Amount. Under this Agreement, the Child Care Provider shall provide Services of \$175 for each child per week.

VIII. Payment Method. The Payment Amount shall be paid: (check one)

IX. Deposit. The Parent(s) is/are: (check one)

- **Required** to pay a deposit in the amount of \$85 (plus \$50 for every additional child) to the She Cares Daycare as security and may be applied for any damage made on the premises by the child(ren) or for any unpaid balances by the parent(s) for any services provided. If the deposit is used by She Cares Daycare for any reason, then She Cares Daycare shall demand the deposit of the aforementioned fee amount be repaid or this agreement shall terminate within five (5) business days.
- **Not required** to pay a deposit before the Child Care Provider is able to provide their Services.

X. Absent. If any child(ren) are to be absent, She Cares Daycare requires that at least 24 hours notice be provided. Absent days will not be deducted from the cost of services.

XI. Vacation Times. The following vacation times shall be administered to each party: (check all that apply):

- Parents are allotted 10 non-pay days. These 10 days can be used in lieu of payment to cover absences and vacations. The parent(s) must provide at least 7 day(s) notice before their child(ren) is on vacation. During the parent(s) vacation, the parent(s) are required not required to pay for child care services during such vacation.
- She Cares Daycare will provide at least 14 day(s) notice before going on vacation.

XII. Damages. If any of the child(ren), while under the child care provider's supervision, causes any damage to the premises other than normal wear and tear on toys, furniture, or damage, the parent(s) shall be responsible for repairing any said damage caused by the child(ren).

XIII. Governing Law. This agreement shall be governed by and in accordance with the laws in the state of Missouri.

XIV. Severability. If any term, covenant, condition, or provision of this agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of the provisions shall remain in full force and effect and shall in no way be affected, impaired, or invalidated.
